PARKING: Students/Renters are not permitted to park in the lot behind PCOTC during weekday hours. You may park in the lot after 5:00 p.m. weekdays, and on weekends. If parking in the lot, your car must be in a designated space; you may not park next to the ramp. Please be aware that illegally parked cars are subject to towing.

CLEANUP: Please be aware of where your dog's nose is (if they are looking at it, they are thinking about it) when entering and exiting the facility, as well as what his/her rear end is doing!

For those dogs in season, please make sure panties are worn when inside the facility. Please clean up any bodily fluids thoroughly with the appropriate agents and if they eliminate on the outside stairs/deck, please rinse it off. Thank you for your help in keeping PCOTC clean!

Agility Tip: Training in a Tight Space

Tight on time and space this winter? Here is one of my favorite setups to use in a tight space. It lends itself to train many handling skills. Here are two examples of how to handle this particular se-

quence. It allows you to train two different handling skills and two different lines for the dog.

Obedience Tip: You Get What You Reinforce

I have become very sensitive about my placement of reinforcement this past year because of all the work I am doing with Heeling. My Border Collie, Disco, finds heeling to be particularly challenging because he loves to forge, and lives in extension! I never realized that I was creating some of this problem. I thought I was being so careful! Then it was pointed out to me that whenever I played with him I presented the toy in front on heel position. This created a dog that loved to come in front of me, thus creating a forging position. I have also observed many of my students creating similar problems with their own dogs.

Tips For reinforcement:

• Find the correct Heel position for your dog in terms of his body type and size. Ask your instructor or a knowledgeable friend

to assist you if you are not sure.

- Sit your dog in Heel position and check yourself in a mirror. Practice sliding your hand down the seam of your pants as you give the dog his reinforcement.
- When using a toy as a reward, try holding the toy in your right hand behind your back. When you release your dog to "get it," your dog will come behind you. Bring them to play tug on your right side.
- Allow your dog to see you place a toy or bait bag on the floor. Set him up for heeling and go forward a few steps. When you want to reward him, release him to the toy behind you.

There are many ways to reinforce your dog for heel work. Just be conscious of how and where you are delivering your reward.

Rally Tip: Trials—The Day After by Ann Mandelbaum, CPDT-KA, © Morgaana Photography


You and your dog were trialing over the weekend. Congratulations if you Q'ed — awesome if you earned a new title! In any case—like they say—you came home with the best dog in the trial.

Whatever your weekend was like, now is the time to cash in on the investment all that preparation and those entry fees represent. How can you augment your training plan going forward in light of your experiences at the trial?

For example: what was your dog's attitude going into the venue? Did he take it all in stride or did it range from over-stimulated to fearful to too interested in other people and dogs or to completely shut down? How did your dog warm up before going into the ring? And did you do your usual routine or did you try something else —perhaps practicing a particular exercise that you were not sure of—and did that help? Was your dog focused and attentive in the ring or distracted by what was happening outside the ring gates—or by the judge? Could you get him back easily once he was distracted?

How about you? When you walked into the ring, do you think you were the same handler you are in daily practice sessions? If you were nervous, do you honestly think your feelings could have affected your dog's behavior? Were there any incidents before your class, perhaps when you were first setting up, perhaps when you were leaving the ring or at any other time, between your dog and a person or another dog, that you wish hadn't occurred? Were you happy about where you set up—in terms of traffic, ease of access to the ring or the outside door or anything else?

I think by now you may have a clue as to the point of this exercise. Try to go over every detail of the whole day—not only with regret ("oh if only I had done...") nor smug satisfaction ("I sure nailed..."). Rather try to find the spots you can manage better next time to protect you both from uncomfortable situations and, even more importantly, work to deepen his commitment to you and his trust that the object of this trial game is this—the more distractions he can resist the better the reward will be at the end! Isn't that the best skill you can teach your dog?

This year, again, all registration will be done through www.dogmatchshows.com. Each obedience run is \$10 for Novice, Open, and/or Utility, plus a \$2 handling fee. The major advantage is the ability to choose your time slot. In the event that you cannot make your scheduled entry, please send a friend. There will be no refunds or carrying over to the next match.

Rally Run-Thrus:

Registration will be handled via Jotform at \$10 per run, and one free run will be available to volunteers.

Time alloted for run-thrus is depending on the class:

- 5 minutes per run for Novice, Intermediate, and Advanced.
- 7 minutes for Master and Excellent.

There will be a two-ring setup, with Novice through Advanced in one ring and Master-Excellent in the second ring.

Family Manners

Family Manners Tip: Impulse Control by Cindy Rubin, CPDT-KA

Most of the people starting out on the journey of training their dogs have the same concerns: how to train their dogs not to pull on the leash, not to jump on people, not to chase squirrels or cars. Notice a pattern? What is missing from their dog's behavior is self-control.

Impulse control is the dog's ability to resist sudden urges. The dog wants something and doesn't know how to wait for it or how to leave it. As responsible pet owners and trainers we must help the dogs to control themselves.

Dogs have physical, mental and social needs. If these needs aren't met, it will

be much harder for the dog to focus and control itself. Have a daily exercise routine for your dog, long walks, training sessions, playing tug or fetch can all tire your dog physically and mentally. If your dog is still "hyper" by the end of the day it could be that his routine is not enough. Fun classes like Nose Work and Tricks can also give your dog added stimulation.

Teaching your dog to focus on you is the number one step in training and helping to improve impulse control. Start by reinforcing the behavior you want. Every time your dog gives you eye contact mark this behavior with your clicker or your marker word, give a treat, and wait. If your dog

looks away, wait and see if he looks back at you. A perfect opportunity to mark and reward! In the beginning, you may need to prompt eye contact with a sound or slight movement, but once he learns that eye contact gets him a cookie and praise it will be offered. Remember, reward a calm dog that is sitting or standing. Build focus up to 5-10 seconds. Once your dog can focus on you, you can start to work on manners training. Have your dog sit and wait for his leash, the door to open, leaving his crate, and for dinner to be served.

There are other ways to build impulse control such as "Leave It," "Settle," and "Go To Mat." All are helpful with early training.

The Owner Handler Association of America

Showing dogs is one of very few sports where amateurs and professionals can compete for the same prize. The Professional Handlers Association (PHA) has represented professional handlers since 1926. It wasn't until 1967 when a group of dog fanciers recognizing the need for an organization formed the Owner Handler Association (OHA). The OHA is the voice of owner-handlers.

OHA is a national association dedicated to the sport of purebred dogs and devoted to the education of the owner handler. Its members span across the U.S and Canada.

The objectives of the OHA are:

- To encourage and promote the sport of owner handling and training of purebred dogs.
- To encourage and promote sportsman-

ship among purebred dog fanciers.

• To communicate with and educate purebred fanciers.

The OHA and the PHA are the only emblems that the American Kennel Club allows exhibitors to wear in the ring.

OHA publishes a newsletter, *The Advocate*, which covers what is going on in the organization and prints articles of general interest to the fancy.

Each year OHA offers three \$1000.00 scholarships.

AKC Delegate's Report

Third Quarter 2018 — by Kathy Gregory, PCOTC Delegate to AKC

The AKC has announced several brand new, exciting programs that are worth looking into in the New Year:

Free Webinar Series

First, there is a free webinar series on a variety of topics of interest to all dog lovers and competition enthusiasts. It's the *AKC Education Webinar Series* and will usually be held on the last Wednesday of every month, but sometimes more frequently. To find upcoming topics go to the AKC website, AKC.ORG. On the top banner select Expert Advice, then scroll down to AKC Public Education Webinar Series. You can ask questions and participate in open discussions. There is no limit to how many club members can join in on the site.

Some of the topics are/were

- The Evolution of Dog Sports (Held on 10/29)
- Show Secretary's Responsibilities
- Website Best Practices
- Using the Online Event Management System
- Misconduct
- Government relations
- Archiving

This is a wonderful opportunity to sit at home in your bunny slippers and participate in interesting discussions on topics you might otherwise always wonder about. Upcoming topics also include how to use social media to get the word out about club events. It's free, so give it a try!

Fit Dog Program

The AKC has also launched a *FIT DOG* program for dog owners who reach a specified fitness goal. Now don't turn off—it's easy to qualify! The AKC and The American Heart Association have joined together to offer a really cute, free magnet for those who exercise regularly by walking with their dogs! The American Heart Association recommends 30-40 minutes of walking per day or 150 minutes per week

and what better way is there to fulfill this recommendation and stay healthy than to walk your dog?

You can order your free magnet when you and your dog have met one of these fitness goals:

- 1. Walked at least 30 minutes 5 times per week for a total of at least 150 minutes per week for at least 3 months. For dogs and people in good shape.
- 2. Walked at least 15 minutes per session at least 10 times per week (e.g., two 15-min walks per day) for at least 3 months. For dogs or people who would benefit from a walk that is a shorter duration, e.g., senior dogs.

How to Get Your Magnet

- 1. Complete your walks. Keep a record so you will know when you've met your goal.
- 2. Go to the AKC website and search for the Fit Dog Program
- 3. Complete the Magnet Order Form. It's that simple!
- 4. Note: If you are already taking your dog on regular walks, you may count those.

Remember that before starting an exercise program for your dog, it is a good idea to consult with your veterinarian.

Detection Dog Program

There was an update on the proposed detection dog program. It was reiterated that the AKC will not be involved in the program unless arrangements are made for lifetime veterinary care of dogs in the program. The four breeds involved at this point are Labs, GSPs, Vizslas and GWPs. The program is moving forward and a specific genome has been identified as being necessary in breeding detection dogs. Sporting dogs are most in demand. This is a very serious effort of the part of many experts in the AKC to work with law enforcement and Homeland Security to fill the great demand for domestically bred

detection dogs. I am proud of the AKC for making this demand and always keeping the health of the dogs first.

"Low Entry" Breeds

Addressing another area of concern, Dr. Carmen Battaglia, AKC Board Liaison, presented an up-dated analysis of "low-entry" breeds and their gradual disappearance from conformation events between 2010 and 2017. He stated that 2017 represented the 15th consecutive year of decline in conformation entries. Eighty per cent of the 3,500 conformation shows last year had fewer than 1,000 entries. There are approximately 1,400 conformation events/ year in the U.S., with an average entry of 852. Each of the new breeds added to the AKC studbooks during the last 10 years demonstrates a decline in numbers of dogs and of litters registered. Limited registrations, which began in 1998 with 275 litters, reached an all-time high in 2017 with 122,500 limited registrations. Dr. Battaglia referenced Dr. Jerold Bell's contention that a breed had to grow and expand to remain healthy.

Canine Insurance

The Delegate's Education portion of our September meeting involved experts from two insurance companies that specialize in insurance for the equine and canine industry. Equisure and McGriff Insurance companies sent representatives to discuss the value of insuring our clubs and businesses against the financial hardship that can be caused by even a small, frivolous claim. They also spoke about a rising concern for clubs, Cyber liability, stemming from the possibility of hackers getting into a club's membership information and using private data for nefarious purposes.

I look forward to continuing to serve the best interests of the club in all our areas of interest, for all breeds and allbreeds!

Jan. 19: AKC ACT Trial

On Saturday, January 19, PCOTC hosted its first ever ACT trial and the largest ACT trial held yet, with a total of 84 entries. Exhibitors attended a one-hour pre-trial seminar presented by ACT Evaluator Grace Heck, which covered a variety of topics from how to read a Premium and enter a trial, to how to walk a course and obtain your results. Twenty-eight exhibitors then competed in up to two rounds of the ACT1, which includes 9-12 obstacles such as jumps, tunnels, table, and A-frame.

Following the ACT1, there was an additional one-hour seminar covering helpful

tips and tricks collected from a range of current Agility competitors. This seminar included information such as how to find out about trials, where to keep your dog on trial day, things to bring, and tracking your results for the long term. All seminar information was provided in a helpful packet so that participants could continue to reference it in the future. The seminar was fun and interactive, with current Agility competitors chiming in with information they wished they had known when starting out. Fifteen exhibitors then competed in up to two rounds of the ACT2 which included 9-12 obstacles such as jumps, tunnels,

table, A-frame, teeter, and 6 weave poles. There were 40 Q's over the course of all four rounds, with 12 competitors earning new titles.

Congratulations to all competitors, and thank you to everyone who volunteered and helped this event run smoothly. A very special thank you to Anita Ambani, our fearless trial secretary, and evaluator Grace Heck. We are actively seeking volunteers for Trial Secretary for future ACT events. In this seminar she focused on analyzing dogs lines and finding the most efficient route on course. Stefanie helped teams determine which handling techniques were best suited for individual teams that helped achieve optimal results.

Saturday also offered Handling Techniques with Grace Heck as teams learned the more advanced handling techniques you might need to navigate International style courses, including how to handle wraps, slices, threadles, and backsides. Grace broke down each technique into its individual components, then use them in sequences. She discussed when and where to use each technique, as well as considerations for individual teams.

Sunday, Novice/Young Dog Sequencing Teams spent the day training with Stefanie on short sequences. Only jumps and tunnels were used in this seminar. The focus was on analyzing dogs lines and finding the most efficient route on course. Teams learned when, why, and how to incorporate particular handling techniques into a sequence and practiced multiple handling techniques throughout the day.

Also on Sunday, Handling in Tight Spaces with Grace Heck Teams spent the day training with Grace on short sequences that challenged participating teams discrimination skills and emphasized precision in cueing their handling plan. Grace discussed how to keep dogs moving and engaged as teams navigated tight courses. Thank you Stefanie & Grace for a wonderful weekend of Learning!





PCOTC members did well—as usual:







Volunteering Explained

Volunteers run all PCOTC activities except dog training, for which we pay qualified instructors. We ask each club member to volunteer a minimum of 12 hours during each club year (January 1 to December 31). Those who complete the minimum of 12 hours receive special Member Volunteer rates that provide year-round savings on all group classes.

In order to receive the special volunteer rates for a club year, members must complete their volunteer hours prior to the beginning of that club year.

Volunteer hours do not "carry over" from year to year. Each member in a family membership needs credit for 12 volunteer hours, but family members may credit hours to another person in the membership.

New club members must complete 6 volunteer hours prior to submitting their application for membership, and are eligible for the Volunteer Member privileges immediately upon admission to the club. They then must complete an additional 6 hours prior to the end of the club year to receive Volunteer Member status for the next year.

You can find volunteer opportunities in the Help Wanted column in *Sit 'n Stay*, on the PCOTC Events bulletin board at the facility or by contacting our Volunteer Coordinator at pcotcvolunteer@gmail.com.

It is your responsibility to report your volunteer hours via a PCOTC Volunteer Reporting Form, kept in stock at the facility. The form is also available for download from the Membership page of our web site, http://www.pcotc.org/membership.

Volunteer members who log in 30+ hours in a club/fiscal year are considered "Super Volunteers" who will be honored at the annual club meeting and given a Certificate of Appreciation.

Note: Due to a Bylaws change, our fiscal and club years are now Jan. 1 through Dec. 31. Volunteer hours in one calendar year are used to retain volunteer status in the following calendar year.
